學費:

中一至中五級全年學費為港幣\$3,060,由2025年9月至2026年6月,分10期繳交(每月\$306)。 (上述學費為本校向教育局申請調整後之收費,有待教育局審批。若上述學費未獲教育局批准,中一至中五級全年學費將維持2024-25全年學費港幣\$2,910;每月\$291)。

2025年9月至2026年6月學費,本校將於每月6號至12號期間通過銀行自動轉賬過戶收取該月之學費,而2025年9月及10月份學費將於2025年10月初分兩次以自動轉賬收取,請責家長由2025年10月份開始於每月5號之前存放足夠款項,以便扣賬。若存款不足,銀行將會每次收取手續費。若同學於十月仍未辦妥自動轉賬手續,則需到校務處以現金交費,敬請垂注。

備註: 若學校沒有調整下學年學費或學校未獲教育局批准調整下學年學費,各級學生升級後的全年 學費將與原先升班前的全年學費相同

申請學費減免事宜:

1. 各級學費減免計劃:

為就讀本校有經濟需要的學生提供學費減免。

- 2. 申請資格:
 - (a) 申請人必須為香港居民及
 - (b) 申請人為本校學生家長或合法監護人。
 - (c) 申請人必須符合下列其中一項條件:
 - (i) 已向學生資助處申請「2025-2026學年學校書簿津貼計劃、學生車船津貼計劃及上網費 津貼計劃」,並已獲學生資助處初步評估為**全額資助**或**半額資助**(請附學生資助處 「2025/26資格評估申請結果通知書」或「2025/26學生資助處資格証明書」副本作實)。
 - (ii) 已獲社會福利署批核的綜合社會保障援助(綜援)。(請附有關證明文件作實,例:申請 獲准通知書)
 - (iii) 有特殊經濟需要可向本校申請。

3. 申請程序:

- (a) 學校於開學時派發有關「繳交學費及申請學費減免通告」及「學費減免計劃申請表」。
- (b) 申請人若於 2025 年 9 月 12 日(星期五)或之前將已填妥的學費減免申請表連同有關證明文件副本、「繳交學費及申請學費減免通告」回條交回校務處。本校會於 10 月初發出第一批的學費減免計劃的結果通知書。
- (c) 若有關文件或申請資料不足,申請將不獲進一步處理。
- (d) 若申請人在 2025 年 9 月 12 日(星期五)以後才遞交申請,可交往班主任或校務處。申請學生的學費減免將可能由批核日期起生效。
- (e) 學費減免計劃截止申請日期為 2026 年 6 月 30 日。
- (f) 有關申請的批核與否,學費減免的款額或有關學費減免事宜等,校方具有最終的決定權。



5. 上訴機制程序:

- (a) 若家長要求覆核學費減免幅度,可於「學費減免結果通知書」發出日起計算的3星期內要求 覆核其申請。
- (b) 每學年只可覆核壹次。家長需遞交書面信,列出充份理由,並連同有關證明文件交回本校會 計部處理。
- (c) 收妥文件後,由負責財務組的副校長覆核學費減免申請,會計部於3星期內回覆家長其結果。

6. 提供/處理個人資料:

- (a) 申請人有責任詳實填妥申請表及提供所有證明文件。本校將根據申請人所遞交的資料來評估 減免資格及幅度。填報的資料如欠詳盡,申請將不獲進一步處理。
- (b) 本校會將申請表上的個人資料作下列用途:

 - (ii) 追討多付的減免款項(如適用);
 - (iii) 核對在本校儲存的個人資料;
 - (iv) 統計及研究;以及
 - (v) 供本校作處理其他與學費減免有關的申請。
- (c) 申請人所提供的資料,本校可因應上文第6段所提及的用途,或在法例授權或規定須予披露的情況下,向政府各局/部門及有關學校披露。
- (d) 本校或會聯絡其他政府部門及機構,核實填報的資料。若在申請書上誤報或漏報資料,申請 人的申請資格可能被取消及/或被要求全數歸還已發放的減免金額,更可能被檢控。
- (e) 倘若因計算或評估錯誤而導致申請人多獲得發放減免,申請人必須退還差額。

Kowloon Sam Yuk Secondary School 2025-2026 School Year

S.1-S.5 School Fee & Fee Remission Scheme

School Fee:

The annual school fee for S.1-S.5 is HKD \$3,060. The fee will be paid in 10 monthly installments from September 2025 to June 2026 (HKD \$306 per month). (Please note that the school fee is subject to approval by the Education Bureau. If disapproved, the annual school fee will remain at HKD\$2,910 (HKD\$291 per month), unchanged from the previous school year.)

From September 2025 to June 2026, the school will collect school fees via autopay between the 6th and 12th of each month. For September and October 2025, school fees will be collected in two installments at the beginning of October. Parents are requested to ensure sufficient funds are deposited before the 5th of each month starting in October 2025 to avoid bank transaction fees. If the setup of autopay services is not completed by October, payments must be made in cash at the school office.

Note: If the school does not adjust the school fee for the next school year or does not receive approval from the Education Bureau for the adjustment, the annual school fees for students after promotion will remain the same as that before promotion.

Application for School Fee Remission:

- 1. School Fee Remission Scheme:
 - To provide school fee remission for students with financial needs who is enrolled at our school.
- 2. Eligibility Criteria:
 - (a) Applicant must be Hong Kong resident;
 - (b) Applicant must be the parent or legal guardian of our student;
 - (c) Applicant must meet **one** of the following conditions:
 - (i) Has already received the application result from the Student Finance Office for the "2025-2026 School Textbook Assistance Scheme, Student Travel Subsidy Scheme and Subsidy Scheme for Internet Access Charges" and has been qualified for <u>full</u> or <u>half</u> subsidy (Please provide a copy of the 2025/26 "Eligibility Assessment Result Notification" or "Eligibility Certificate" as proof).
 - (ii) Has been granted Comprehensive Social Security Assistance (CSSA) by the Social Welfare Department. (Please provide supporting documents as proof, such as an official approval notice)
 - (iii) Has a special financial needs. The applicant may apply to our school.
- 3. Application Process:
 - (a) The "Notice of School Fee Payment and Application for School Fee Remission Scheme" and the "Application Form for School Fee Remission Scheme" will be provided at the commencement of the school year.
 - (b) Applicant who submits the completed school fee remission scheme application form, along with copies of supporting documents and the reply slip of the "Notice of School Fee Payment and Application for School Fee Remission Scheme," to the school office by **September 12, 2025 (Friday)** or earlier, will receive the assessment results in early October.
 - (c) If any required documents are missing or incomplete, the application will not be further processed.
 - (d) If an application is submitted after September 12, 2025 (Friday), it can be submitted to the class teacher or the school office. School fee waivers for late applications may take effect from the approval date.
 - (e) The deadline for application for the school fee remission scheme is **June 30, 2026**.
 - (f) The school reserves the final decision on the approval of applications, waiver amounts, and related matters.

4. Assessment of Eligibility for Waivers and Extent of School Fee Remission:

- (a) The school will assess applications based on the results issued by the Student Finance Office or the documentation provided by the Social Welfare Department.
- (b) The extent of school fee remission is as follows:

The extent of school fee remission will be based on either the assessment results issued by the Student Finance Office or the documentation issued by the Social Welfare Department.

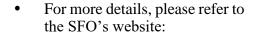

5. Review and Appeal:

- (a) Any request for a review of school fee remission must be submitted within three weeks from the date of issuance of the 'Notification of School Fee Remission Results'.
- (b) Eligibility appeals are limited to one per school year. Parents must submit a written letter stating their reasons and provide relevant supporting documents to the school's accounting department for the appeal process.
- (c) The Vice Principal in the finance department will handle all reviews and appeals, and the finalized results will be notified by the accounting department within three weeks after the submission.

6. Provision / Processing of Personal Data:

- (a) The applicant is responsible for providing detailed and accurate information in the application form and all supporting documents. The school will assess the eligibility and extent of school fee remission based on the information submitted by the applicant. If any required documents are missing or incomplete, the application will not be further processed.
- (b) The personal data collected from the application form will be used by the school for the following purposes:
 - (i) Processing and verification of information;
 - (ii) Reclaiming overpaid fee remission (if applicable);
 - (iii) Cross referencing with the data stored by the school;
 - (iv) Data analysis and research; AND
 - (v) Providing the reference database for other fee remission application processes.
- (c) The data provided by the applicant, in addition to the purposes stated in section (6), may be submitted to the government authorities/departments and relevant educational institutions as required by laws or regulations.
- (d) The school may verify the information in the application form with other government departments and agencies. If any false or incomplete information is discovered, the applicant's eligibility and/or granted remission may be revoked, requiring full repayment, and further legal action may be taken.
- (e) If a miscalculation or inaccurate assessment leads to the applicant receiving an excessive amount of remission, the applicant is required to refund the corresponding difference.
- (f) All submitted documents will not be returned. In accordance with the Personal Data (Privacy) Ordinance (Cap. 486 Personal Data (Privacy) Ordinance s.18 & s.22), the applicant has the right to access and correct their personal data in the application form. Moreover, to obtain a copy of the submitted documents, the applicant is required to submit a written request to the school and pay an administrative fee.
